FIRST ORDER OF BUSINESS

Call to Order/Roll Call

FOURTH ORDER OF BUSINESS

Consideration of Hanson, Walter & Associates, Inc. Letter of Agreement for Construction Management Services for Close-Out

Mr. Torres presented the Hanson, Walter & Associates, Inc. Letter of Agreement for Construction Management Services for Close-Out for the ED3 Hughes Brothers project.

Discussion ensued regarding the Construction Services Contract, the County, inspections by the City and if the Contract can be modified if there is an overlap of responsibilities.

On MOTION by Mr. Kramer and seconded by Mr. Wanas, with all in favor, the Hanson, Walter & Associates, Inc. Letter of Agreement for Construction Management Services for Close-Out, subject to an amendment depending on inspection findings/requirements, was approved.

Presentation of Terms of Bond Sale

Referencing a handout, Mr. Gonzalez reviewed the bond pricing information. He highlighted the following:

- \$28 million worth of bonds were sold through pre-term bonds.
- The first bond matures in 2031, the second bond matures in 2044 and the third bond matures in 2054.
- The average interest rate on the shorter bond is 4.5%, the middle range bond is 5.25% and the longer-range bond is 5.5%.
- The terms of the bond sale are set forth on Page 93 of the PDF.
